**WAIVER AND RELEASE OF LIABILITY FOR PARTICIPATION IN TOURS AND EVENTS  
HELD WITHIN THE RIVERSIDE CHURCH BELL TOWER**

In exchange for participation in tours and events held with The Riverside Church Bell Tower (the "Activity"), organized by The Riverside Church in the City of New York, 490 Riverside Drive, New York, NY, 10027, ("Releasee"), I hereby, for myself and anyone claiming on my behalf, agree as follows:

I knowingly and voluntarily enter into this waiver and release of liability and hereby release and forever discharge the Releasee, its affiliates, managers, members, agents, attorneys, staff, volunteers, or representatives (collectively, the "Released Parties"), in their individual and/or corporate capacities from any and all claims, liabilities, obligations, promises, agreements, disputes, and damages, including those related to any physical or psychological injury, including but not limited to illness, paralysis, death, economical or emotional loss, that I may suffer as a direct result of my participation in the Activity ("Claims").

I understand that participation in the Activity involves physical activity that carries with it inherent risks, including risk of physical or psychological injury, pain, suffering, illness, disfigurement, temporary or permanent paralysis, and/or death, and I assume all risks, known and unknown, and voluntarily participate in the Activity. These risks may include, but are not limited to, those caused by terrain, facilities, temperature, weather, lack of hydration, condition of participants, equipment, and actions of others, including but not limited to the Releasee and Released Parties. I further agree to observe all posted rules and instructions and will follow all instructions I may receive from the Released Parties while participating in the Activity.

I agree to indemnify and hold harmless the Releasee against any and all claims, suits or actions of any kind whatsoever for liability, damages, compensation or otherwise brought by me or anyone on my behalf, including attorney fees and any related costs, if litigation arises pursuant to any claims made by me or by anyone else acting on my behalf.

In the event that I should require medical care or treatment as a consequence of my participation in the Activity, I agree to be financially responsible for any costs incurred as a result of such treatment. I am aware and understand that I should carry my own health insurance.

In the event that any damage to equipment or facilities occurs as a result of my or my family's willful actions, neglect or recklessness, I acknowledge and agree to be held liable for any and all costs associated with any actions of neglect or recklessness.

I acknowledge I have carefully read, understand, and agree to this "Waiver and Release" and expressly agree to release and discharge The Riverside Church in the City of New York and its Released Parties from any and all claims.
