She is a Professor of Political Science at Brooklyn College, CUNY, and has served as the past Women's Studies Program Director and past Deputy Chair for Graduate Studies in the Department of Political Science at Brooklyn College. She specializes in International Political Economy with a regional focus on the African continent, particularly Nigeria.

She formally joined Riverside Church in 2022 and is an active member of the African Fellowship, Antiracism Taskforce, and Morning Prayer. Additionally, she participates actively in the Book Club, OBS, and Coffee Hour, and occasionally joins the Writing Group. She has led the planning and delivery of programs sponsored by the African Fellowship and Education Commission

I have taught, published extensively, and conducted public speaking engagements on these topics. Additionally, I have mentored younger academic and professional colleagues, particularly women, both formally and informally. I am eager to bring these skills and experiences to Riverside.

Tawanna Huguley's professional background encompasses domestic and international work as an Executive Leader in Risk Management and Human Resources across multiple industries.
